"The additional materials organize information about the stages and issues that businesses can encounter during commercial litigation, from early dispute assessment through settlement discussions or court proceedings," said Ken Schuster, Esq., founding member of Schuster Law. "The firm intends the material to explain those processes in a format that can be referenced as commercial disputes develop."

The July additions include information about filing a commercial litigation lawsuit, settlement procedures in business disputes, claims involving lost business profits, and steps that can follow an alleged contract breach. These publications supplement earlier 2026 materials addressing the duration of commercial

litigation, distinctions between general and commercial litigation, alternatives to court proceedings, and common categories of business disputes.

Schuster Law maintains a commercial litigation practice that includes representation in business-related civil disputes. The firm identifies contract disputes, shareholder disagreements, professional malpractice matters, employment disputes, landlord-tenant matters, and other commercial conflicts among the issues that can lead to litigation. Depending on a dispute and the governing agreements, a matter can proceed in state court, federal court, arbitration, mediation, or another dispute-resolution forum.

Commercial litigation generally begins when parties disagree about contractual obligations, business relationships, financial responsibilities, property interests, or other legal duties. Pleadings establish the parties' formal positions, discovery provides a process for exchanging relevant information, and motions allow courts to address legal or procedural questions before trial. Settlement discussions or alternative dispute resolution can occur at different stages of the proceeding.

Contract disputes represent one category of commercial litigation addressed in the firm's materials. A contract dispute can concern performance obligations, payment terms, interpretation of written provisions, warranties, confidentiality requirements, or an alleged failure to perform an agreed obligation. Courts and arbitrators review the language of applicable agreements along with communications, business records, testimony, and other evidence relevant to the disputed terms.

Shareholder and partnership disputes can involve a different collection of records and legal questions. Operating agreements, shareholder agreements, financial statements, corporate records, correspondence, and transaction documents can become relevant when parties disagree about management authority, ownership interests, distributions, fiduciary obligations, or the operation of a business. The appropriate procedure depends on the legal claims, business structure, governing documents, and forum involved.

Schuster Law's litigation resources also describe the procedural stages associated with filing and defending commercial claims. The materials address pre-litigation review, pleadings, discovery, motion practice, negotiation, settlement, and trial as separate components of the litigation process. The firm publishes the materials as general information and states that website content does not create an attorney-client relationship or constitute individualized legal advice.
